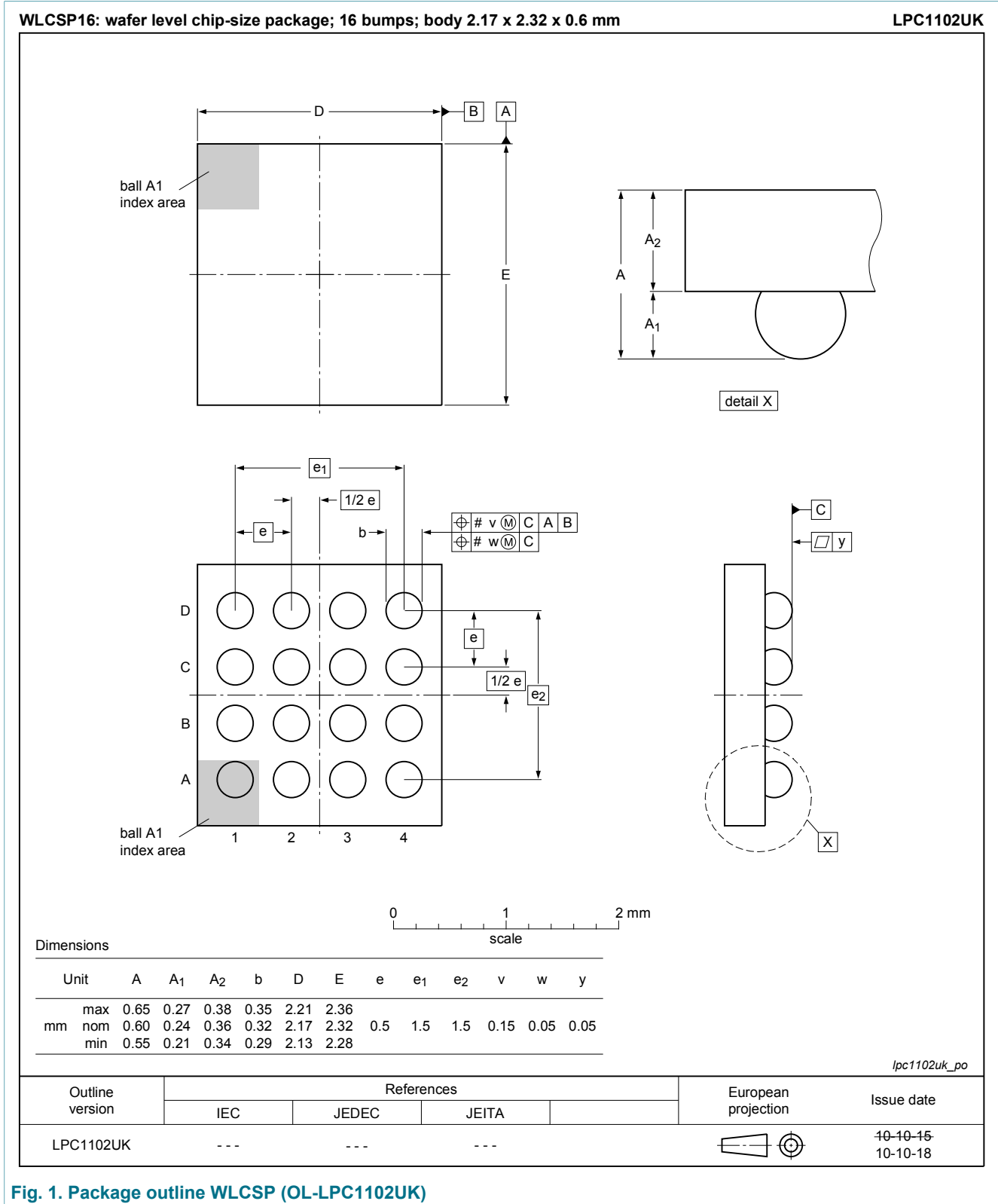


Fig. 1. Package outline WLCSP (OL-LPC1102UK)
