Subject: Philips Semiconductors' Product Discontinuation Notice Number DN-56, Correction Notice

Dear Philips Semiconductors' Customer or Distributor:

This letter outlines certain corrects and changes to information contained in Philips December 31, 2005 Product Discontinuation Notice Number DN-56 as follows:

1. Reference Exhibit A to DN-56 ("SOD87 Rectifier and Zener TVS Discontinued Part Types"):

A. On January 26, 2006, Philips' Bipolar Product Line, Business Line Power Management issued a Discontinued Product Correction Notice Entitled "Change of Availability Status of SOD87 Products". A copy of this notice letter is attached to and made part of this DN-56 Correction Notice for your review.

The attached January 26th Philips' Business Line Notice letter amends the specific SOD87 Part Types that were incorrectly stated in Philips' December 31, 2006 DN-56 Exhibit A as having a Code 3 ("Unlimited Supply Availability"). The ordering supply availability for these SOD87 Part Types is hereby corrected to indicate that these Part Types actually have a Code 2 ("Limited Availability").

This Limited Availability condition is due to Philips' restricted production and technical capability for continued manufacturing of these specific SOD87 Products. Therefore, Philips' customers and distributors for these SOD87 products need to place their final last time buy orders "As Soon As Possible" (now by March 31, 2006) to insure the highest degree of confidence that Philips can meet your last time supply requirements.

Refer to the attached Philips January 26, 2006 letter for the affected SOD87 Part Types and more information. Additionally we recommend that you consult Philips" Business Line, Bipolar Product Marketing Management for more specific details details and current SOD87 product availability status.

B. SOD87 Product Replacement Correction:

In addition to the revised Product Availability change for the SOD87 Products, there is an additional correction for the below listed SOD87 Part Types regarding "Product Replacement" information. The below listed SOD87 Part Types originally had "Product Replacement Information" stated on both DN-56, as well as on Philips Business Line January 26, 2006 Notice Letter referenced above. Philips hereby corrects this information to now correctly show that there are NO KNOWN REPLACEMENT PRODUCTS for the below listed SOD87 Part Types.
